# CCHREI's Mission Statement

To ensure an adequate supply of people with demonstrated skills and knowledge required to meet the environmental human resources needs of the public and private sectors.

- Manage on-line certification systems for competency-based certification
  - Reliant on the National Occupational Standards for Environmental Employment





# CECAB's Mission and Mandate

#### Mission

 CECAB will provide national certification for competent Canadian environmental practitioners.

#### Mandate

 As a professional autonomous body, CECAB will administer an efficient and effective program for the certification of competent Canadian environmental practitioners.





### What is an Environmental Practitioner?

Any person who performs work activities that contribute to the protection of the environment, the conservation of its natural resources (including the prevention, abatement and control of pollution), and environmental communications, research and education.

- ✓ Cross-sectoral
- ✓ Multi-disciplinary
- ✓ Knowledge based





#### **CCEP and CEPIT Certification**

- CCEP: "Canadian Certified Environmental Practitioner"
  - Primary credential
  - Available to experienced practitioners
  - Ensures that a defined standard has been met
  - Denotes environmental competency in chosen subsectors
- CEPIT: "Canadian Environmental Practitioner-in-Training"
  - Training credential
  - Stepping stone toward CCEP certification
  - Provides a mechanism for career development





# HR in the Environment Industry

- 9,550 public & private sector organizations
- a workforce of 221,000 people
- 4,200 positions vacant (January 1999)
- 78% of organizations actively recruiting

# Implementation of the Agreement

- Certifications will not change
- Certification process to be integrated within the CECAB on-line application system
- Certification systems to transition from Can-P 1412 to ISO 17024 DIS with support of the Standards Council of Canada
- Transition process to be monitored by joint CEAA/CCHREI/CECAB committee to ensure that:
  - rigour is maintained
  - applicants in process continue without delay
  - accreditation is maintained
