# Why Is OHSMS Auditing Emerging

- Companies do not want to injure or kill their employees
- Pressure from stakeholders and other interested parties regarding health, safety and environmental issues
- Corporate initiatives regarding social accountability and sustainable work practices
- Greater public awareness

#### How Did We Get Here?

- Workers Compensation Board Occupational Health & Safety Regulation
- ISO 9000 and ISO 14001 First International "quality and environmental management systems" standards
- CSA Z 1000 Occupational Health & Safety Management (draft 2)
- OHSAS 18001 occupational health and safety management system (Appears to be the most dominant)
- ILO Guidelines on Health & Safety Management Systems

# Why Do We Need Them?

- \$ 908,353,308 Compensation claim costs in BC during 2003
- 2,765,230 Days lost due to claims in BC during 2003
- Employee and visitor safety in the work place
- Corporate costs in relation to lost time accidents
- Evolution from "command & control" to selfregulation and continuous improvement



#### Purposes of OHSMS Standards

As with EMS & QMS programs the purpose is to:

- Set benchmarks for pro-active management practices
- Improve occupational health and safety performance using voluntary mechanisms
- Allow for verification to stakeholders; and
- Decrease opportunities to "cover-up"

# Scope of An OHSMS


Again as with EMS & QMS Programs the scope:

- Does not set technical or media-specific standards
- Compliance to legal requirements is a minimum
- Puts occupational health and safety management on top management's agenda
- Integration of occupational health and safety management into all business functions -> leverage resources
- Based on PLAN->DO->CHECK->ACT

# OHSMS Principles & P-D-C-A

- Commitment and policy;
- Planning and prioritization;
- Implementation;
- Measurement and evaluation; and
- Review and improvement

The same principles as used for EMS & QMS Programs



# **OHSMS** Auditing

#### Objectives of an OHSMS Audit

- To determine OHSMS conformance to the audit criteria
- To determine if OHSMS is properly implemented and maintained
- To identify areas of potential improvement
- To assess ability of internal management review process to ensure continuing suitability and effectiveness of the OHSMS
- To evaluate OHSMS of a supplier organization

# **OHSMS** Auditing

#### Principles of Auditing

- Objectives and Scope
- Independence / Objectivity
- Technical Expertise / Skills
- Confidentiality (Due Professional Care)
- Defined Audit Criteria
- Defined Audit Process (Reliability)

#### Is There A Demand For OHSMS

#### Most Definitely:

- More and More Multi-National Companies will not deal with organization's who do not have formal Health & Safety Programs
- The opportunity to decrease costs associated with claims is significant
- The opportunity to decrease the number of injuries is significant

#### Potential For Work
